18. APPLICATION FOR GEOLOGICAL SURVEY PERMIT; DEL NORTE, HUMBOLDT, MENDOCINO, SONOMA, MARIN, SAN FRANCISCO, SAN MATEO, SANTA CRUZ, MONTEREY, SAN LUIS OBISPO, SANTA BARBARA, VENTURA, LOS ANGELES, ORANGE AND SAN DIEGO COUNTIES; UNION OIL COMPANY OF CALIFORNIA - W.O. 6544, P.R.C. 3754.1.

After consideration of Calendar Item 2 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO ISSUE TO UNION OIL COMPANY OF CALIFORNIA A GEOLOGICAL SURVEY PERMIT, CONFORMING TO ALL OPERATING CONDITIONS ESTABLISHED BY THE COMMISSION FOR THE CONDUCT OF GEOLOGICAL SURVEY OPERATIONS, ON THOSE TIDE AND SUBMERGED LANDS UNDER THE JURISDICTION OF THE STATE LANDS COMMISSION IN THE AREA LYING BETWEEN THE NORTHERN BOUNDARY AND THE SOUTHERN BOUNDARY OF THE STATE OF CALIFORNIA. THE PERMIT IS TO BE ISSUED FOR A SIX-MONTH PERIOD FROM APRIL 27, 1967 THROUGH SEPTEMBER 26, 1967. THE PERMITTEE IS TO REIMBURSE THE STATE LANDS DIVISION FOR ANY INSPECTION COSTS.

An application has been received from Union Oil Company of California for a permit to conduct geological survey operations in order to drill core holes in California state waters from the northern boundary of the State of California to the southern boundary of the State of California. The statutory filing fee has been paid by the applicant.

IT IS RECOMMENDED THAT THE COMMISSION AUTHORIZE THE EXECUTIVE OFFICER TO ISSUE TO UNION OIL COMPANY OF CALIFORNIA A GEOLOGICAL SURVEY PERMIT, CONFORMING TO ALL OPERATING CONDITIONS ESTABLISHED BY THE COMMISSION FOR THE CONDUCT OF GEOLOGICAL SURVEY OPERATIONS, ON THOSE TIDE AND SUBMERGED LANDS UNDER THE JURISDICTION OF THE STATE LANDS COMMISSION IN THE AREA LYING BETWEEN THE NORTHERN BOUNDARY AND THE SOUTHERN BOUNDARY OF THE STATE OF CALIFORNIA.
