10. DREDGING PERMIT, NAPA RIVER, NAPA COUNTY; CITY OF NAPA - W.O. 6429,
P.R.C. 3763.9.

After consideration of Calendar Item 44 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO ISSUE A PERMIT TO THE CITY OF NAPA TO DREDGE APPROXIMATELY 4400 CUBIC YARDS OF MATERIAL, WITHOUR PAYMENT OF ROYALTY, FROM AN AREA OF STATE-OWNED LAND WITHIN THE BED OF THE NAPA RIVER IN THE FOLLOWING-DESCRIBED AREA:

A PARCEL OF TIDE AND SUBMERGED LAND IN THE NATURAL BED OF THE NAPA RIVER, NAPA COUNTY, CALIFORNIA; LYING APPROXIMATELY ONE MILE SOUTHERLY OF IMOLA AVENUE BRIDGE; BEING FURTHER DESCRIBED AS FOLLOWS:

BEGINNING AT A POINT IN THE BED OF THE NAPA RIVER WHICH BEARS N.6° 58' 17" W. 2,743.13 FEET MORE OR LESS FROM A 3 $\frac{1}{4}$ INCH IRON PIPE MONUMENT L.S. 2956 AT THE SOUTHWEST CORNER OF THE PARCEL OF LAND AS SHOWN ON THE MAP ENTITLED "RECORD OF SURVEY OF A PORTION OF NAPA STATE HOSPITAL", ON FILE IN BOOK 6 OF SURVEYS AT PAGES 56, 57, AND 58, NAPA COUNTY RECORDS, NAPA, CALIFORNIA; THENCE FROM SAID POINT OF BEGINNING S. 21° 38' 24" E. 330.16 FEET; THENCE N. 68° 21' 36" E. 274.00 FEET; THENCE N. 21° 38' 24" W. 170.00 FEET; THENCE N. 81° 20' W. 317.37 FEET TO THE POINT OF BEGINNING; CONTAINING 1.57 ACRES OF LAND.

THE CONSIDERATION FOR THE ISSUANCE OF THIS PERMIT IS TO BE THE PUBLIC BENEFIT.

APPLICATION FOR DREDGING PERMIT, TIDE AND SUBMERGED LANDS, NAPA RIVER, NAPA COUNTY; CITY OF NAPA - W.O. 6429.

An application has been received from the City of Napa for a permit to dredge approximately 4400 cubic yards of material from the Napa River, approximately one mile south of the City of Napa, for the construction of a boat-launching ramp on the Napa River adjacent to John F. Kennedy Memorial Park. State funds are being used in the project and the facility will be operated by the City of Napa. Dredged material unsuitable for the construction of the ramp will be deposited on property of the City of Napa.

Section 6303 of the Public Resources Code provides that when an applicant has a permit from the Federal Government, the Commission may grant the privilege of depositing material upon or removing or extracting material from tide or submerged lands owned by the State for the improvement of navigation or reclamation, upon such terms and conditions and for such consideration as will be for the best interests of the State.

The U.S. Army Corps of Engineers has issued a permit authorizing dredging at the proposed location. The Department of Parks and Recreation, Division of Beaches and Parks, has stated that the permit would have no effect upon any project or program of that Department. The Department of Fish and Game reports that it does not anticipate that this project will have an adverse effect on the fishery resources of the Napa River. The Department of Water Resources reports concern regarding the compatibility of the proposed work with future construction in connection with the U.S. Army Corps of Engineers flood-control project in the area.

IT IS RECOMMENDED THAT THE COMMISSION AUTHORIZE THE EXECUTIVE OFFICER TO ISSUE A PERMIT TO THE CITY OF NAPA TO DREDGE APPROXIMATELY 4400 CUBIC YARDS OF MATERIAL, WITHOUT PAYMENT OF ROYALTY, FROM AN AREA OF STATE-OWNED LAND WITHIN THE BED OF THE NAPA RIVER IN THE FOLLOWING-DESCRIBED AREA:

BEGINNING AT A POINT IN THE BED OF THE NAPA RIVER WHICH BEARS N. 6° 58' 17" W. 2,743.13 FEET MORE OR LESS FROM A 3½ INCH IRON PIPE MONUMENT L.S. 2956 AT THE SOUTHWEST CORNER OF THE PARCEL OF LAND AS SHOWN ON THE MAP ENTITLED "RECORD OF SURVEY OF A PORTION OF NAPA STATE HOSPITAL", ON FILE IN BOOK 6 OF SURVEYS AT PAGES 56, 57, AND 58, NAPA COUNTY RECORDS, NAPA, CALIFORNIA; THENCE FROM SAID POINT OF BEGINNING S. 21° 38' 24" E. 330.16 FEET; THENCE N. 68° 21' 36" E. 274.00 FEET; THENCE N. 21° 38' 24" W. 170.00 FEET; THENCE N. 81° 20' W. 317.37 FEET TO THE POINT OF BEGINNING; CONTAINING 1.57 ACRES OF LAND.
