11. DREDGING PERMIT, SUNSET AQUATIC REGIONAL PARK, ORANGE COUNTY; ORANGE COUNTY HARBOR DISTRICT - W.O. 6487, P.R.C. 3764.9.

After consideration of Calendar Item 45 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO ISSUE A PERMIT TO THE ORANGE COUNTY HARBOR DISTRICT TO DREDGE APPROXIMATELY 110,000 CUBIC YARDS OF MATERIAL, WITHOUT PAYMENT OF ROYALTY, FROM AN AREA OF STATE-OWNED TIDE AND SUBMERGED LANDS AT THE SUNSET HARBOR AQUATIC REGIONAL PARK, AND TO DEPOSIT THE MATERIAL ON PARK LANDS OF THE HARBOR DISTRICT. THE STATE LANDS TO BE DREDGED ARE: THOSE TIDELANDS IN THE COUNTY OF ORANGE, STATE OF CALIFORNIA, MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BEGINNING AT THE INTERSECTION OF THE NORTHWESTERLY LINE OF RANCHO LA BOLSA CHICA WITH THE EASTERLY TERMINUS OF THAT CERTAIN COURSE IN THE SOUTHERLY LINE OF LOT 1, SHOWN AS HAVING A BEARING OF S. 83° 15' 00" E. AND A DISTANCE OF 425.02 FEET, ON TRACT NO. 893, AS SHOWN BY MAP RECORDED IN BOOK 27, PAGES 23 AND 24, OF MISCELLANEOUS MAPS, IN THE OFFICE OF THE COUNTY RECORDER, COUNTY OF ORANGE, STATE OF CALIFORNIA; THENCE S. 49° 28' 00" W. ALONG THE NORTHWESTERLY LINE OF THE RANCHO LA BOLSA CHICA 1179.75 FEET; THENCE N. 73° 45' 00" W. 818.27 FEET; THENCE N. 52° 45' 00" W. 611.83 FEET MORE OR LESS TO THE SOUTHWESTERLY PROLONGATION OF THAT CERTAIN COURSE IN THE SOUTHERLY LINE OF LOT 1, SHOWN AS HAVING A BEARING OF S. 60° 00' 00" W. APPLICATION FOR DREDGING PERMIT, TIDE AND SUBMERGED LANDS, SUNSET AQUATIC REGIONAL PARK, ORANGE COUNTY; ORANGE COUNTY HARBOR DISTRICT - W.O. 6487.

The Orange County Harbor District has applied for a permit to dredge approximately 110,000 cubic yards of material from State tidelands in conjunction with the Sunset Aquatic Regional Park development. The dredging will improve the navigable waterways in the area. The dredged material will be deposited on park lands owned by the Orange County Harbor District.

Section 6303 of the Public Resources Code provides that when an applicant has a permit from the Federal Government, the Commission may grant the privilege of depositing material upon, or removing or extracting material from, tide or submerged lands owned by the State for the improvement of navigation, upon such terms and conditions and for such consideration as will be for the best interests of the State.

The U. S. Army Corps of Engineers has issued a letter of permission authorizing the proposed dredging. The Department of Parks and Recreation, Division of Beaches and Parks, reports that the proposed dredging will not interfere with the recreational use of lands littoral to the tidelands or submerged lands involved.

The Department of Water Resources has recommended that the Orange County Harbor District be granted a permit to dredge the area described in the application.

The Department of Fish and Game has reviewed the application and has no objection to the issuance of the permit.
