13. DREDGING PERMIT, FALSE RIVER AND PIPER SLOUGH, CONTRA COSTA COUNTY; DEPARTMENT OF GENERAL SERVICES, OFFICE OF ARCHITECTURE AND CONSTRUCTION -W.O. 6270, P.R.C. 3766.9.

After consideration of Calendar Item 46 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO ISSUE TO THE DEPARTMENT OF GENERAL SERVICES, OFFICE OF ARCHITECTURE AND CONSTRUCTION, A PERMIT TO DREDGE APPROXI-MATELY 35,000 CUBIC YARDS OF MATERIAL, WITHOUT PAYMENT OF ROYALTY, FROM AN AREA OF TIDE AND SUBMERGED LANDS IN THE BEDS OF FALSE RIVER AND PIPER SLOUGH, CONTRA COSTA COUNTY. THE AREA TO BE INCLUDED IN THE PERMIT IS DESCRIBED ON EXHIBIT "A" ATTACHED AND BY REFERENCE MADE A FART HEREOF. THE CONSIDERATION FOR THE ISSUANCE OF THIS PERMIT IS TO BE THE FUBLIC BENEFIT.

APPLICATION FOR DREDGING PERMIT, TIDE AND SUBMERGED LANDS, FALSE RIVER AND PIPER SLOUGH, CONTRA COSTA COUNTY; DEPARTMENT OF GENERAL SERVICES, OFFICE OF ARCHITECTURE AND CONSTRUCTION - W.O. 6270.

An application has been received from the Department of General Services, Office of Architecture and Construction, for a permit to dredge approximately 35,000 cubic yards of material from an area of tide and submerged lands in the beds of False River and Piper Slough, adjacent to Frank's Tract State Recreation Area, for the purpose of repairing and widening the levee located on property under the jurisdiction of the Department of General Services, Office of Architecture and Construction.

Section 6303 of the Public Resources Code provides in part that: "The Commission may grant the privilege of...extracting material from...tide or submerged lands...for improvement of navigation, reclamation or flood control or for purposes connected with the erection or maintenance of structures... on such terms and conditions and for such consideration as will be for the best interests of this State."

The U. S. Corps of Engineers has informed the applicant that due to the small amount of earthwork involved, and proximity to the shoreline, no Department of the Army permit will be required.

The Reclamation Board has issued an order, Application No. 5639, approving the proposed operations.

Ine Department of Fish and Game has reviewed the application and has requested that as a condition of the permit, the applicant be required to:

- 1. Maintain the amount of turbidity caused by dredging activities at a level of not greater than 10 percent increase in the background turbidity.
- 2. Conduct operations in a manner consistent with any waste discharge requirements prescribed by the appropriate Regional Water Quality Control Board.

IT IS RECOMMENDED THAT THE COMMISSION AUTHORIZE THE EXECUTIVE OFFICER TO ISSUE TO THE DEPARTMENT OF GENERAL SERVICES, OFFICE OF ARCHITECTURE AND CONSTRUCTION, A PERMIT TO DREDGE APPROXIMATELY 35,000 CUBIC YARDS OF MATERIAL, WITHOUT PAYMENT OF ROYALTY, FROM AN AREA OF TIDE AND SUBMERGED LANDS IN THE BEDS OF FALSE RIVER AND PIPER SLOUGH, CONTRA COSTA COUNTY. THE AREA TO BE INCLUDED IN THE PERMIT IS DESCRIBED ON EXHIBIT "A" ATTACHED AND BY REFERENCE MADE A PART HEREOF. THE CONSIDERATION FOR THE ISSUANCE OF THIS PERMIT IS TO BE THE PUBLIC BENEFIT.
