## EXHIBIT "A"

A strip of tide and submerged land 100 feet wide across the bed of the San Joaquin River, Sacramento and Contra Costa Counties, situate approximately 4 miles northeasterly of the Antioch Bridge; lying 50 feet on each side of the following described centerline:

Beginning at a point on the last natural Mean High Tide Line of the southeasterly bank of the San Joaquin River which bears S.  $51^{\circ}$  24' 37.5" W. 1,433.28 feet, and N. 42° 22' 00" W. 19.39 feet, more or less, from U.S.C.& G.S. Triangulation Station "False 1931" said Triangulation Station has California Zone 3 coordinate values of X = 1,658,969.65, Y = 567,982.82; thence from the point of beginning N. 42° 22' 00" W. 1,908 feet, more or less to a point on the last natural Mean High Tide Line of the northwesterly bank of the San Joaquin River; containing 4.38 acres more or less.
