29. EXTENSION OF TERM OF GEOLOGICAL SURVEY PERMIT P.R.C. 2764.1; SAN LUIS OBISPO SOUTH THROUGH ORANGE COUNTY; TEXACO INC.

After consideration of Calendar Item 9 attached, and upon motion duly made and carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO ISSUE TO TEXACO INC. AN EXTENSION OF THE TERM OF GEOLOGICAL SURVEY PERMIT P.R.C. 2764.1 FOR THE PERIOD JULY 28, 1967, THROUGH JANUARY 27, 1968, ON THOSE TIDE AND SUBMERGED LANDS UNDER THE JURISDICTION OF THE STATE LANDS COMMISSION IN THE AREA LYING BETWEEN A LINE DRAWN DUE WEST FROM POINT SAN LUIS, SAN LUIS OBISPO COUNTY, AND THE PROLONGATION SEAWARD OF THE NORTHWESTERLY LIMITS OF THE CITY OF NEWPORT BEACH, ORANGE COUNTY. ALL OTHER TERMS AND CONDITIONS OF THE PERMIT ARE TO REMAIN UNCHANGED AND IN FULL FORCE AND EFFECT.

APPLICATION FOR EXTENSION OF TERM OF GEOLOGICAL SURVEY PERMIT P.R.C. 2764.1; SAN LUIS OBISPO, SANTA BARBARA, VENTURA, LOS ANGELES, AND ORANGE COUNTIES; TEXACO INC.

An application has been received from Texaco Inc. for an extension of the term of Geological Survey Permit P.R.C. 2764.1 for the period July 28, 1967, through January 27, 1968, in order to continue core-drilling operations. The present permit will expire on July 27, 1967.

IT IS RECOMMENDED THAT THE COMMISSION AUTHORIZE THE EXECUTIVE OFFICER TO ISSUE TO TEXACO INC. AN EXTENSION OF THE TERM OF GEOLOGICAL SURVEY PERMIT P.R.C. 2764.1 FOR THE PERIOD JULY 28, 1967, THROUGH JANUARY 27, 1968, ON THOSE TIDE AND SUBMERGED LANDS UNDER THE JURISDICTION OF THE STATE LANDS COMMISSION IN THE AREA LYING BETWEEN A LINE DRAWN DUE WEST FROM POINT SAN LUIS, SAN LUIS OBISPO COUNTY, AND THE PROLONGATION SEAWARD OF THE NORTHWESTERLY LIMITS OF THE CITY OF NEWPORT BEACH, ORANGE COUNTY.
