30. EXTENSION OF TERM, GEOLOGICAL SURVEY PERMIT P.R.C. 2831.1; SAN LUIS OBISPO SOUTH THROUGH SAN DIEGO COUNTY; HUMBLE OIL & REFINING COMPANY.

After consideration of Calendar Item 10 attached, and upon motion duly made and carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO ISSUE TO HUMBLE OIL & REFINING COMPANY AN EXTENSION OF THE TERM OF GEOLOGICAL SURVEY PERMIT P.R.C. 2831.1 FOR THE PERIOD JULY 22, 1967, THROUGH JANUARY 21, 1968, ON THOSE TIDE AND SUBMERGED LANDS UNDER THE JURISDICTION OF THE STATE LANDS COMMISSION IN THE AREA LYING BETWEEN A LINE FORMING THE NORTHERN BOUNDARY OF SAN LUIS OBISPO COUNTY AND THE SEAWARD EXTENSION THEREOF AND THE SEAWARD EXTENSION OF THE SOUTHERN BOUNDARY OF THE STATE OF CALIFORNIA. ALL OTHER TERMS AND CONDITIONS OF THE PERMIT ARE TO REMAIN UNCHANGED AND IN FULL FORCE AND EFFECT.

APPLICATION FOR EXTENSION OF TERM OF GEOLOGICAL SURVEY PERMIT P.R.C. 2831.1; SAN LUIS OBISPO, SANTA BARBARA, VENTURA, LOS ANGELES, ORANGE, AND SAN DIEGO COUNTIES; HUMBLE OIL & REFINING COMPANY.

An application has been received from Humble Oil & Refining Company for an extension of the term of Geological Survey Permit P.R.C. 2831.1 from July 22, 1967, through January 21, 1968, in order to continue core-drilling operations. The present permit will expire on July 21, 1967.

IT IS RECOMMENDED THAT THE COMMISSION AUTHORIZE THE EXECUTIVE OFFICER TO ISSUE TO HUMBLE OIL & REFINING COMPANY AN EXTENSION OF THE TERM OF GEOLOGICAL SURVEY PERMIT P.R.C. 2831.1 FOR THE PERIOD JULY 22, 1967, THROUGH JANUARY 21, 1968, ON THOSE TIDE AND SUBMERGED LANDS UNDER THE JURISDICTION OF THE STATE LANDS COMMISSION IN THE AREA LYING BETWEEN A LINE FORMING THE NORTHERN BOUNDARY OF SAN LUIS OBISPO COUNTY AND THE SEAWARD EXTENSION THEREOF AND THE SEAWARD EXTENSION OF THE SOUTHERN BOUNDARY OF THE STATE OF CALIFORNIA.
