

31. EXTENSION OF TERM, GEOPHYSICAL EXPLORATION PERMIT P.R.C. 3092.1; MENDOCINO SOUTH THROUGH SAN DIEGO COUNTY; HUMBLE OIL & REFINING COMPANY.

After consideration of Calendar Item 11 attached, and upon motion duly made and carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO ISSUE TO HUMBLE OIL & REFINING COMPANY AN EXTENSION OF THE TERM OF GEOPHYSICAL EXPLORATION PERMIT P.R.C. 3092.1 FOR THE PERIOD AUGUST 1, 1967, THROUGH JANUARY 31, 1968, ON THOSE TIDE AND SUB-MERGED LANDS UNDER THE JURISDICTION OF THE STATE LANDS COMMISSION IN THE AREA LYING BETWEEN A LINE FORMING THE NORTHERN BOUNDARY OF MENDOCINO COUNTY AND THE SEAWARD EXTENSION THEREOF AND THE SOUTHERN BOUNDARY OF THE STATE OF CALIFORNIA AND THE SEAWARD EXTENSION THEREOF EXCEPT THE FOLLOWING:

1. SAN FRANCISCO BAY AND OTHER INLAND WATERS DRAINING THEREIN;
2. LAND INCLUDED IN SECTION 6871.2(b) OF THE PUBLIC RESOURCES CODE;
3. LANDS LYING ADJACENT TO THE MAINLAND BETWEEN A LINE FORMING THE NORTH-WESTERLY BOUNDARY OF THE CITY OF NEWPORT BEACH, ORANGE COUNTY, AND THE SEAWARD EXTENSION THEREOF, AND A LINE FORMING THE SOUTHEASTERLY BOUNDARY OF ORANGE COUNTY AND THE SEAWARD EXTENSION THEREOF.

ALL OTHER TERMS AND CONDITIONS OF THE PERMIT ARE TO REMAIN UNCHANGED AND IN FULL FORCE AND EFFECT.

APPLICATION FOR EXTENSION OF TERM OF GEOPHYSICAL EXPLORATION PERMIT P.R.C. 3092.1; MENDOCINO, SONOMA, MARIN, SAN FRANCISCO, SAN MATEO, SANTA CRUZ, MONTEREY, SAN LUIS OBISPO, SANTA BARBARA, VENTURA, LOS ANGELES, ORANGE, AND SAN DIEGO COUNTIES; HUMBLE OIL & REFINING COMPANY.

An application has been received from Humble Oil & Refining Company for an extension of the term of Geophysical Exploration Permit P.R.C. 3092.1 for the period August 1, 1967, through January 31, 1968, in order to continue geophysical-exploration operations. The present permit will expire on July 21, 1967.

IT IS RECOMMENDED THAT THE COMMISSION AUTHORIZE THE EXECUTIVE OFFICER TO ISSUE TO HUMBLE OIL & REFINING COMPANY AN EXTENSION OF THE TERM OF GEOPHYSICAL EXPLORATION PERMIT P.R.C. 3092.1 FOR THE PERIOD AUGUST 1, 1967, THROUGH JANUARY 31, 1968, ON THOSE TIDE AND SUBMERGED LANDS UNDER THE JURISDICTION OF THE STATE LANDS COMMISSION IN THE AREA LYING BETWEEN A LINE FORMING THE NORTHERN BOUNDARY OF MENDOCINO COUNTY AND THE SEAWARD EXTENSION THEREOF AND THE SOUTHERN BOUNDARY OF THE STATE OF CALIFORNIA AND THE SEAWARD EXTENSION THEREOF EXCEPT THE FOLLOWING:

1. SAN FRANCISCO BAY AND OTHER INLAND WATERS DRAINING THEREIN;
2. LAND INCLUDED IN SECTION 6871.2(b) OF THE PUBLIC RESOURCES CODE;
3. LANDS LYING ADJACENT TO THE MAINLAND BETWEEN A LINE FORMING THE NORTHWESTERLY BOUNDARY OF THE CITY OF NEWPORT BEACH, ORANGE COUNTY, AND THE SEAWARD EXTENSION THEREOF, AND A LINE FORMING THE SOUTHEASTERLY BOUNDARY OF ORANGE COUNTY AND THE SEAWARD EXTENSION THEREOF.

ALL OTHER TERMS AND CONDITIONS OF THE PERMIT ARE TO REMAIN UNCHANGED AND IN FULL FORCE AND EFFECT.
