34. MODIFIED FORM OF PROSPECTING PERMIT FOR GEOTHERMAL RESOURCES - W.O. 4493D.

After consideration of Calendar Item 34 attached, and upon motion duly made and carried, the following resolution was adopted:

THE COMMISSION:

1. APPROVES AND ADOPTS, PURSUANT TO DIVISION 6 OF THE PUBLIC RESOURCES CODE, THE MODIFIED FORM OF PROSPECTING PERMIT APPROVED MARCH 31, 1966 (MINUTE ITEM 29, PAGE 12,432), AS AMENDED IN EXHIBIT "A" ATTACHED, AS THE FORM TO BE UTILIZED FOR PROSPECTING PERMITS FOR GEOTHERMAL RESOURCES.
2. AUTHORIZES THE EXECUTIVE OFFICER TO APPLY THE AMENDMENT TO EXISTING PERMITS WITH THE CONSENT OF THE PERMITTEE.

## MODIFIED FORM OF PROSPECTING PERMIT FOR GEOTHERMAL RESOURCES - W.O. 4493D.

On March 31, 1966 (Minute Item 29, page 12,432), the State Lands Commission approved and adopted a modified form of prospecting permit to be used for geothermal resources. Paragraph 4 of the permit requires the permittee to complete 480 work shifts during the two-year term of the permit. It is proposed to modify paragraph 4 to include the methods used in geothermal exploration. The modification is shown on Exhibit "A" attached; the added words are underlined.

## IT IS RECOMMENDED THAT THE COMMISSION:

1. APPROVE AND ADOPT, PURSUANT TO DIVISION 6 OF THE PUBLIC RESOURCES CODE, THE MODIFIED FORM OF PROSPECTING PERMIT APPROVED MARCH 31, 1966 (MINUTE ITEM 29, PAGE 12,432), AS AMENDED IN EXHIBIT "A" ATTACHED, AS THE FORM TO BE UTILIZED FOR PROSPECTING PERMITS FOR GEOTHERMAL RESOURCES.
2. AUTHORIZE THE EXECUTIVE OFFICER TO APPLY THE AMENDMENT TO EXISTING PERMITS WITH THE CONSENT OF THE PERMITTEE.

4. Permittee shall commence within six (6) months from date hereof the work of prospecting for the said geothermal energy, minerals and mineral waters for which this Prospecting Permit has been issued upon some portion of the land covered hereby and shall conduct the same in a good workmanlike manner and shall complete at least forty (40) shifts per month for not less than four (4) months prior to the expiration of one (1) year from date hereof. A shift is hereby defined and agreed to be not less than eight (8) hours work for one man, or may include geological, geophysical, geothermal, geochemical or other exploratory work. Permittee shall make available to the Commission copies of all factual and physical exploration results, logs and records resulting from operations under this permit. Such data shall be for the confidential use of the Commission and shall not be open to inspection by any other person or agency without the written consent of the permittee. Such data shall include all exploratory data applicable to the permit area and to all adjacent lands in which the permittee has any right, title or interest. Permittee shall complete during the second year of the term of this Prospecting Permit at least forty (40) shifts per month for a period of not less than eight (8) months in said second year.
