RENEWAL OF INTERAGENCY AGREEMENT WITH DEPARTMENT OF GENERAL SERVICES, OFFICE OF ARCHITECTURE AND CONSTRUCTION - S.W.O. 8287

On May 27, 1965, the State Lands Commission authorized the Executive Officer to execute an Interagency Agreement with the Department of General Services, Office of Architecture and Construction, providing for delineating, drafting, and engineering services for the preservation of valuable land-sales records. The project remains incomplete, and funds for the continuation of this service were budgeted and are available in the 1967-68 fiscal year in the amount of \$12,600.
