5. DREDGING PERMIT, MOSS LANDING HARBOR, MONTEKEY COUNTY; MOSS LANDING HARBOR DISTRICT - W.O. 6652, P.R.C. 3796.9.

After consideration of Calendar Item 23 attached, and upon motion duly made and carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO ISSUE A PERMIT TO THE MOSS LANDING HARBOR DISTRICT TO ACCOMPLISH MAINTENANCE DREDGING, AND TO DREDGE APPROXIMATELY 25,200 CUBIC YARDS OF MATERIAL, WITHOUT PAYMENT OF ROYALTY, FROM TWO AREAS OF STATE-OWNED TIDE AND SUBMERGED LANDS IN MOSS LANDING HARBOR AND MORE COJO SLOUGH, AND TO DEPOSIT THE MATERIAL IN MONTEKEY BAY AT THE SEWARD END OF THE PIER APPROXIMATELY ONE-THIRD OF A MILE SOUTH OF THE ENTRANCE CHANNEL TO THE HARBOR. THE CONSIDERATION FOR THE ISSUANCE OF THIS PERMIT IS THE PUBLIC BENEFIT.

APPLICATION FOR DREDGING PERMIT, TIDE AND SUBMERGED LANDS, MOSS LANDING HARBOR, MONTEREY COUNTY; MOSS LANDING HARBOR DISTRICT - W.O. 6652.

An application has been received from the Moss Landing Harbor District for a permit to perform maintenance dredging by removing approximately 25,200 cubic yards of material from the bed of Moss Landing Harbor in Monterey County. The dredge areas lie within an area granted by the State to the Moss Landing Harbor District (Ch. 1190, Stats. 1947). The material will be deposited in Monterey Bay off the bayward end of the pier located approximately one-third of a mile south of the entrance channel to the harbor.

Section 6303 of the Public Resources Code provides that when an applicant has a permit from the Federal Government, the Commission may grant the privilege of depositing material upon, or removing or extracting material from, tide or submerged lands owned by the State for the improvement of navigation or reclamation upon such terms and conditions and for such consideration as will be for the best interests of the State.

The applicant has been issued a permit by the U. S. Corps of Engineers that authorizes the proposed dredging operations. The Division of Beaches and Parks, the Department of Fish and Game, and the Department of Water Resources have been notified of the proposed dredging.

IT IS RECOMMENDED THAT THE COMMISSION AUTHORIZE THE EXECUTIVE OFFICER TO ISSUE A PERMIT TO THE MOSS LANDING HARBOR DISTRICT TO ACCOMPLISH MAINTENANCE DREDGING, AND TO DREDGE APPROXIMATELY 25,200 CUBIC YARDS OF MATERIAL, WITHOUT PAYMENT OF ROYALTY, FROM TWO AREAS OF STATE-OWNED TIDE AND SUBMERGED LANDS IN MOSS LANDING HARBOR AND MORO COJO SLOUGH, AND TO DEPOSIT THE MATERIAL IN MONTEREY BAY AT THE BAYWARD END OF THE PIER APPROXIMATELY ONE-THIRD OF A MILE SOUTH OF THE ENTRANCE CHANNEL TO THE HARBOR. THE CONSIDERATION FOR THE ISSUANCE OF THIS PERMIT IS THE PUBLIC BENEFIT.
