6. RIGHT-OF-WAY EASEMENT, RUSSIAN RIVER, SONOMA COUNTY; PACIFIC GAS AND ELECTRIC COMPANY - W.O. 6537, P.R.C. 3797.1.

After consideration of Calendar Item 1 attached, and upon motion duly made and carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO ISSUE TO PACIFIC GAS AND ELECTRIC COMPANY A 15 YEAR RIGHT-OF-WAY EASEMENT, IN CONSIDERATION OF ANNUAL RENT IN THE AMOUNT OF \$49.39, FOR CONTINUED MAINTENANCE OF A POWER DISTRIBUTION LINE ON THE LAND DESCRIBED ON EXHIBIT "A" ATTACHED AND BY REFERENCE MADE A PART HEREOF, WITH LESSEE'S RIGHT TO RENEW FOR THREE ADDITIONAL PERIODS OF TEN YEARS EACH UPON SUCH REASONABLE TERMS AND CONDITIONS AS THE STATE MIGHT IMPOSE.

RIGHT-OF-WAY EASEMENT

APPLICANT: Pacific Gas and Electric Company

LOCATION: One parcel of tide and submerged land in Russian River at
Bridge Haven, Sonoma County

PROPOSED USE: To maintain an existing 12 kv power line

TERMS: Initial period: 15 years
Renewal options: 3 additional periods of 10 years each

CONSIDERATION: \$49.39 per annum

BASIS FOR CONSIDERATION:
6.62% of appraised value of land

EXHIBIT "A"

A strip of tide and submerged land 25 feet wide extending across the Russian River situate near Bridge Haven, Sonoma County, California; lying 12.5 feet on each side of the following-described centerline:

Commencing at triangulation station "B.M. 29" which has California Zone II coordinate values of $X = 1,684,383.08$, $Y = 282,075.52$; thence S. $89^{\circ} 29' 20''$ E., 249.5 feet; S. $30^{\circ} 10'$ E., 70 feet more or less to a point on the Mean High Tide Line of the northerly bank of the Russian River which is the true point of beginning; thence S. $30^{\circ} 10'$ E., 650 feet more or less to the Mean High Tide Line on the southerly bank of the Russian River containing 0.373 acre more or less.

Bearings and distances are grid corresponding to the California Zone II coordinate system.
