An application has been received from Standard Oil Company of California for a permit to conduct seismic exploration operations along the Sacramento River and connecting bays within Township 3 North, Range 2 West; Township 3 North, Range 1 West; Township 2 North, Range 2 West; and Township 2 North, Range 1 West.

The Boards of Supervisors of the counties of Solano and Contra Costa have been informed that this application is to be considered. The applicant has obtained a permit from the Department of Fish and Game covering the same area and specifying that Wildlife Protection Branch of said Department has to be notified if charges in excess of two pounds of explosives would be necessary.

The statutory filing fee has been paid by the applicant.
