3. RIGHT-OF-WAY PERMIT FOR TELEPHONE LINES, SACRAMENTO RIVER, SACRAMENTO AND YOLO COUNTIES; GENERAL TELEPHONE COMPANY - W.O. 6665, P.R.C. 3815.9.

After consideration of Calendar Item 47 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE COMMISSION AUTHORIZES THE EXECUTION OF AN AGREEMENT WITH THE GENERAL TELEPHONE COMPANY, PURSUANT TO PROVISIONS OF SECTION 7901 OF THE PUBLIC UTILITIES CODE AND OF ATTORNEY GENERAL'S OPINION 52-56, FOR THE INSTALLATION AND OPERATION OF TWO TELEPHONE CABLES WITHIN A TEN-FOOT STRIP OF LAND ACROSS SACRAMENTO RIVER, THE CENTER LINE OF WHICH IS DESCRIBED AS FOLLOWS:

BEGINNING AT A POINT IN SACRAMENTO COUNTY ON THE HIGH-WATER LINE OF THE SACRAMENTO RIVER LOCATED 832 FEET NORTH OF SEQUOIA AVENUE NORTH LINE EXTENDED, COURTLAND, CALIFORNIA, AS RECORDED IN SACRAMENTO COUNTY ASSESSORS' MAP BOOK 132, PAGE 18. THENCE N. 47° 15' W. TO A POINT ON THE OPPOSITE BANK OF THE SACRAMENTO RIVER AT THE HIGH-WATER LINE IN YOLO COUNTY.
