APPLICANT: City of Port Hueneme

LOCATION: City of Port Hueneme, Ventura County

PROPOSED USE: For the construction of an extension to an existing pier to be used solely for public fishing.

TERM: Initial period: 49 years, from September 14, 1955

CONSIDERATION: No charge.
The public use and benefit.
To apply only for as long as public use and access is free.

PARCEL "1"

A strip of land 220 feet in width and 500 feet in length, the sidelines being parallel to and located 140 feet easterly of an 80 feet westerly of a line extending seaward S. 35° W., 500 feet from the terminal point of the centerline of Parcel "A". Excepting that portion of the herein described parcel located within Parcel "B".

Containing 1.5 acres more or less.
