5. DREDGING PERMIT, SAN DIEGO BAY, SAN DIEGO COUNTY; SAN DIEGO UNIFIED PORT DISTRICT - W.O. 6675, P.R.C. 3817.9.

After consideration of Calendar Item 45 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE COMMISSION AUTHORIZES THE ISSUANCE OF A PERMIT TO THE SAN DIEGO UNIFIED PORT DISTRICT TO DREDGE APPROXIMATELY 400,000 CUBIC YARDS OF MATERIAL, WITHOUT PAYMENT OF ROYALTY, FROM AN AREA OF SUBMERGED LANDS WITHIN SAN DIEGO BAY DESCRIBED AS FOLLOWS:

BEGINNING AT HARBOR LINE STATION 483 ON THE U. S. PIERHEAD LINE AS SAID PIERHEAD LINE IS NOW ESTABLISHED FOR THE BAY OF SAN DIEGO BY THE CORPS OF ENGINEERS; THENCE SOUTH  $11^{\circ} 42' 45''$  EAST ALONG SAID PIERHEAD LINE A DISTANCE OF 605.17 FEET TO HARBOR LINE STATION 483-A; THENCE CONTINUING SOUTH  $11^{\circ} 42' 45''$  EAST ALONG THE COMBINED U. S. PIERHEAD-BULKHEAD LINE A DISTANCE OF 794.65 FEET; THENCE LEAVING SAID COMBINED U. S. PIERHEAD-BULKHEAD LINE NORTH  $87^{\circ} 17' 56''$  WEST A DISTANCE OF 1,213.36 FEET; THENCE NORTH  $2^{\circ} 42' 04''$  EAST A DISTANCE OF 3,545.00 FEET; THENCE NORTH  $83^{\circ} 24' 28''$  EAST A DISTANCE OF 500.00 FEET TO A POINT ON SAID U. S. PIERHEAD LINE; THENCE SOUTH  $6^{\circ} 35' 32''$  EAST ALONG SAID U. S. PIERHEAD LINE A DISTANCE OF 2,300.00 FEET TO THE POINT OF BEGINNING, CONTAINING 67.28 ACRES;

AND AUTHORIZES DEPOSITION OF THE MATERIAL ALONG THE OCEAN SIDE OF THE SILVER STRAND BEACH, NORTH OF THE SILVER STRAND STATE PARK, THE DEPOSITION TO BE IN ACCORDANCE WITH THE PROVISIONS AS PRESCRIBED BY RESOLUTION 66-R34 ISSUED BY THE SAN DIEGO REGIONAL WATER QUALITY CONTROL BOARD WHICH IS ON FILE IN THE OFFICE OF THE STATE LANDS DIVISION AND BY REFERENCE MADE A PART HEREOF.

APPLICANT: San Diego Unified Port District

IT IS RECOMMENDED THAT THE COMMISSION AUTHORIZE THE ISSUANCE OF A PERMIT TO THE SAN DIEGO UNIFIED PORT DISTRICT, TO DREDGE APPROXIMATELY 400,000 CUBIC YARDS OF MATERIAL, WITHOUT PAYMENT OF ROYALTY, FROM AN AREA OF SUBMERGED LANDS WITHIN SAN DIEGO BAY DESCRIBED AS FOLLOWS:

S. PIERHEAD-BULKHEAD LINE A DISTANCE OF 794.83 FEET; THENCE LEAVING SAID COMBINED U. S. PIERHEAD-BULKHEAD LINE NORTH  $87^{\circ} 17' 56''$  WEST A DISTANCE OF 1,213.36 FEET; THENCE NORTH  $2^{\circ} 42' 04''$  EAST A DISTANCE OF 3,545.00 FEET; THENCE NORTH  $83^{\circ} 24' 28''$  EAST A DISTANCE OF 500.00 FEET TO A POINT ON SAID U. S. PIERHEAD LINE; THENCE SOUTH  $6^{\circ} 35' 32''$  EAST ALONG SAID U. S. PIERHEAD LINE A DISTANCE OF 2,300.00 FEET TO THE POINT OF BEGINNING, CONTAINING 67.28 ACRES;

AND AUTHORIZE DEPOSITION OF THE MATERIAL ALONG THE OCEAN SIDE OF THE SILVER STRAND BEACH, NORTH OF THE SILVER STRAND STATE PARK. THE DEPOSITION TO BE IN ACCORDANCE WITH THE PROVISIONS AS PRESCRIBED BY RESOLUTION 66-R34 ISSUED BY THE SAN DIEGO REGIONAL WATER QUALITY CONTROL BOARD WHICH IS ON FILE IN THE OFFICE OF THE STATE LANDS DIVISION AND BY REFERENCE MADE A PART HEREOF.
