7. RIGHT-OF-WAY PERMIT, MOKELUMNE RIVER, SAN JOAQUIN COUNTY; STATE DEPARTMENT OF FISH AND GAME - W.O. 6633, P.R.C. 3818.9.

After consideration of Calendar Item 5 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE COMMISSION AUTHORIZES THE ISSUANCE TO STATE DEPARTMENT OF FISH AND GAME OF A 49-YEAR RIGHT-OF-WAY PERMIT, IN CONSIDERATION OF THE PUBLIC BENEFIT, FOR INSTALLATION AND PROPER OPERATION OF A PIPELINE APPURTENANT TO A FISH SCREEN ON THE LAND DESCRIBED ON EXHIBIT "A" ATTACHED AND BY REFERENCE MADE A PART HEREOF.

RIGHT-OF-WAY PERMIT

APPLICANT: State Department of Fish and Game

LOCATION: Sovereign land in Mokelumne River at Woodbridge, San Joaquin County

PROPOSED USE: Installation of a bypass pipeline connected with operation of a fish screen at the Woodbridge Irrigation District Diversion Dam

TERMS: Initial period: 49 years

CONSIDERATION: No charge. (The public benefit.)

PREREQUISITE ITEMS:
U.S.A. Corps of Engineers permit not required.
Applicant is lessee or permittee of upland.

EXHIBIT "A"

**** Legal Description ****

Lessee: Department of Fish and Game

W.O. : 6633

A parcel of submerged land situated in the Mokelumne River, County of San Joaquin, State of California, being located in portions of Sections 34 and 35, Township 4 North, Range 6 East, Mount Diablo Base and Meridian, said parcel being six feet wide, lying three feet on either side of the following-described center line:

COMMENCING at the intersection of the center lines of Main Street and Indiana Street in the City of Woodbridge, California, thence South 9° 15' West 210 feet to a point in the center line of Woodbridge Irrigation District Canal; thence South 65° 00' East 175 feet to a point on the Northerly bank of said canal, said point being the TRUE POINT OF BEGINNING.

Thence from said TRUE POINT OF BEGINNING the following four courses:

- 1) North 35° 00' East 695 feet
- 2) North 21° 00' East 765 feet
- 3) North 35° 45' East 260 feet
- 4) North 7° 30' West 45 feet to a point on the Westerly abutment of the Woodbridge Irrigation District diversion dam; said point being North 73° 30' East 10 feet from that certain point, marked with an Iron Monument on the Westerly abutment of said dam, described on map recorded May 11, 1955, in Survey Book 10 or 77, San Joaquin County.

EXCEPTING any portion of the above parcel which may lie above or landward of the ordinary low water mark of the Mokelumne River.
