8. DREDGING PERMIT, SAN PABLO BAY, CONTRA COSTA COUNTY; UNION OIL COMPANY OF CALIFORNIA - W.O. 6681, P.R.C. 3819.9.

After consideration of Calendar Item 56 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE COMMISSION AUTHORIZES THE ISSUANCE OF A PERMIT TO THE UNION OIL COMPANY OF CALIFORNIA TO DREDGE APPROXIMATELY 51,000 CUBIC YARDS OF MATERIAL, WITHOUT PAYMENT OF ROYALTY, FROM AN AREA OF STATE-OWNED SUBMERGED LANDS IN SAN PABLO BAY, DESCRIBED AS FOLLOWS:

THAT PORTION OF THOSE CERTAIN SUBMERGED TIDELANDS LYING WITHIN SAN PABLO BAY, NEAR DAVIS POINT, IN THE COUNTY OF CONTRA COSTA, STATE OF CALIFORNIA, DESCRIBED AS FOLLOWS:

BEGINNING FOR REFERENCE AT THAT CERTAIN POINT IN THE UNITED STATES HARBOR LINE KNOWN AS STATION "U", SAID POINT HAVING GRID COORDINATES $X = 1,493,752.14$, $Y = 569,518.32$ OF ZONE 3 OF THE CALIFORNIA STATE COORDINATE SYSTEM; THENCE N. $1^{\circ} 50' 19''$ W. 2192.95 FEET TO THE NORTHEASTERLY CORNER OF AN EXISTING UNION OIL COMPANY OF CALIFORNIA LOADING WHARF, SAID CORNER HAVING GRID COORDINATES $X = 1,493,681.78$, $Y = 571,710.14$ OF SAID ZONE 3, AND BEING ALSO THE TRUE POINT OF BEGINNING FOR THIS DESCRIPTION; THENCE S. $77^{\circ} 00' 30''$ W. 1250.00 FEET ALONG THE NORTHERLY LINE OF SAID LOADING WHARF; THENCE N. $12^{\circ} 59' 30''$ W. 50.00 FEET; THENCE N. $77^{\circ} 00' 30''$ E. 850.00 FEET; THENCE N. $12^{\circ} 59' 30''$ W. 750.00 FEET; THENCE N. $77^{\circ} 00' 30''$ E. 1200.00 FEET; THENCE S. $32^{\circ} 00' 30''$ W. 1131.37 FEET TO THE TRUE POINT OF BEGINNING; CONTAINING 15.668 ACRES, MORE OR LESS.
