14. RECREATIONAL MINOR-STRUCTURE PERMIT (P.R.C. 3775.1), LAKE TAHOE, EL DORADO COUNTY; ERICKSON INVESTMENT COMPANY - W.O. 6552.

After consideration of Calendar Item 9 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE COMMISSION AMENDS ITS ACTION (MINUTE ITEM 28, p. 484) OF MAY 25, 1967, WHICH AUTHORIZED THE EXECUTIVE OFFICER TO ISSUE TO REYNOLD C. JOHNSON COMPANY A FIVE-YEAR RECREATIONAL MINOR-STRUCTURE PERMIT (P.R.C. 3775.1), SUBSTITUTING ERICKSON INVESTMENT COMPANY AS PERMITTEE.

RECREATIONAL MINOR-STRUCTURE PERMIT

APPLICANT: Erickson Investment Company

LOCATION: Submerged land at Tahoma, Lake Tahoe, El Dorado County

PROPOSED USE: The bottoming of five buoys for mooring boats owned by occupants on onshore multi-family dwellings

TERMS: 5 years

CONSIDERATION: \$125 total for term

BASIS FOR CONSIDERATION:
\$25 total fee for 1-5 years for each buoy

PREREQUISITE ITEMS:
U. S. Army Corps of Engineers navigational permit issued.
Applicant is owner of upland.
