15. RECREATIONAL MINOR-STRUCTURE PERMIT, CLEAR LAKE, LAKE COUNTY; BLAINE R. GORMAN - W.O. 6586, P.R.C. 3825.1.

After consideration of Calendar Item 7 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE COMMISSION AUTHORIZES THE ISSUANCE TO BLAINE R. GORMAN OF A FIVE-YEAR RECREATIONAL MINOR-STRUCTURE PERMIT, IN CONSIDERATION OF TOTAL RENT IN THE AMOUNT OF \$25, FOR CONSTRUCTION AND PROPER MAINTENANCE OF A 3- X 18-FOOT WALKWAY AND AN 8- X 20-FOOT FLOATING DOCK ON SOVEREIGN LAND OF CLEAR LAKE, EXTENDING WATERWARD FROM AN EXISTING 64-FOOT PIER AND LYING PARALLEL WITH AND ADJACENT TO THE WEST PROPERTY LINE, AS EXTENDED NORMAL TO THE SHORE LINE, FROM LOT 80B AS SHOWN ON THAT CERTAIN MAP ENTITLED "CLEAR LAKE VILLAS 4TH RESUBDIVISION, ETC." FILED IN LAKE COUNTY RECORDS ON MARCH 24, 1926, IN BOOK 4 OF TOWN MAPS AT PAGES 117 TO 119, INCLUSIVE.
