27. SALVAGE PERMIT P.R.C. 3535.1 - DEFERMENT OF EFFECTIVE DATE, SAN FRANCISCO BAY, MARIN COUNTY; ALFRED A. MIKALOW - W.O. 3559.

After consideration of Calendar Item 18 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE COMMISSION AUTHORIZES THE DEFERMENT UNTIL AFTER JULY 31, 1968, OF THE ISSUANCE OF A SALVAGE PERMIT (P.R.C. 3535.1) TO ALFRED A. MIKALOW AS PREVIOUSLY AUTHORIZED BY THE COMMISSION ON AUGUST 8, 1966.

SALVAGE PERMIT - DEFERMENT OF EFFECTIVE DATE

APPLICANT: Alfred A. Mikalow

LOCATION: A circular parcel of submerged land in San Francisco Bay, Marin County, having a radius of 4000 feet

PROPOSED USE: Salvage operations on abandoned wrecked vessels now classed as State-owned property

TERMS OF PERMIT AS AUTHORIZED:

Initial period: 3 years, from date of execution by the Executive Officer

Renewal options: 1 additional period of 3 years upon specified conditions.

Surety bond: \$2000

CONSIDERATION: \$25 plus 25% of gross receipts over \$500 from sales of material salvaged

STATUTORY AND OTHER REFERENCES:

- a. Public Resources Code: Div. 6, Pt. 2, Ch. 1, Secs. 6501-6509
- b. Administrative Code: Title 2, Div. 3, Secs. 2000-2011
- c. Commission policy: Minute Item 18 of November 18, 1959

OTHER PERTINENT INFORMATION:

On August 6, 1966, the State Lands Commission authorized the Executive Officer to issue the salvage permit but it was not effectuated because the applicant failed to provide the required bond until July 25, 1967. On July 28, 1967, Mr. Mikalow disclosed that monies earmarked for the operation had been embezzled and he requested that issuance of the permit be deferred until July 31, 1968.
