22. ASSIGNMENT OF PROSPECTING PERMIT FOR GEOTHERMAL ENERGY, P.R.C. 3473.2, GEYSERS AREA, SONOMA AND LAKE COUNTIES; FROM EARTH ENERGY, INC. TO UNION OIL COMPANY OF CALIFORNIA - W.O. 6759.
