30. DREDGING PERMIT, NOYO RIVER, MENDOCINO COUNTY; NOYO HARBOR DISTRICT - W.O. 6504, P.R.C. 3840.1.

After consideration of Calendar Item 23 attached, and upon motion duly made and carried, the following resolution was adopted:

THE COMMISSION AUTHORIZES THE ISSUANCE OF A PERMIT TO THE NOYO HARBOR DISTRICT TO DREDGE APPROXIMATELY 10,000 CUBIC YARDS OF MATERIAL, AT A ROYALDY OF \$0.03 PER CUBIC YARD FOR MATERIAL REMOVED, FROM AN AREA OF GRANTED SUBMIRGED LANDS WITHIN THE BED OF THE NOYO RIVER DESCRIBED AS FOLLOWS:

THAT PORTION OF THOSE LANDS PREVIOUSLY OWNED BY THE STATE OF CALIFORNIA AND CONVEYED BY LEGISLATIVE GRANT IN CHAPTER 555, STATS. 1961, TO THE NOYO HARBOR DISTRICT, SAID CONVEYANCE BEING DELINEATED ON SHEETS 3 AND 4 OF 9, OF A PLAT OF A "SURVEY OF THE ORDINARY HIGH WATER MARK ON THE BANKS OF THE NOYO RIVER - VICINITY OF FORT BRAGG - MENDOCINO COUNTY, CALIFORNIA" FILED IN MAP CASE 1, DRAWER 10 AT PAGE 42, SERIES 12596, RECORDS OF MENDOCINO COUNTY, PREZMED BY THE CALIFORNIA STATE LANDS COMMISSION AND BEING CERTI-FZED ON AUGUST 3, 1955, DESCRIBED AS FOLLOWS:
