34. AUTHORIZATION TO OFFER MINERAL EXTRACTION LEASE, OWENS LAKE, INYO COUNTY (MORRISON AND WEATHERLY CHEMICAL PRODUCTS, APPLICANT) - W.O. 6412.

After consideration of Calendar Item 50 attached, and upon motion duly made and carried, the following resolution was adopted:

THE COMMISSION AUTHORIZES THE OFFERING FOR LEASE, PURSUANT TO COMPETITIVE FUBLIC BIDDING, OF THE AREA OF LAND IN THE BED OF OWENS LAKE, MORE PARTICU-LARLY DESCRIBED IN EXHIBIT "A", AT AN ANNUAL RENTAL OF \$2.50 PER ACRE AND AT A MINIMUM ROYALTY RATE OF SEVENNY CENTS (\$0.70) PER TON FOR ALL MINERALS EXTRACTED AND/OR PRODUCED AND/OR SOLD FROM THE PROPOSED LEASE AREA ON OWENS LAKE.

ROYALTY PAYMENT UNDER THE LEASE WILL BE IN ACCORDANCE WITH THE FOLLOWING SCHEDULE:

$$R = \sqrt{0.70 + 0.10} (C - 8.75) 7 B$$

WHERE R = ROYALTY IN DOLLARS AND CENTS PER TON OF MATERIAL

C = WEIGHTED AVERAGE OF GROSS SALES PRICE PER TON DETERMINED BY THE ACTUAL GROSS SALES VALUE OF THE MATERIAL SOLD ON A QUARTERLY BASIS

B = BID FACTOR (EXPRESSED AS 1.0, 1.1, 1.2, ETC.)

THE MAXIMUM ROYALTY SHALL NOT EXCEED 25 PERCENT OF THE AVERAGE GROSS SALES PRICE OF THE MATERIAL.

THE MINIMUM ROYALITY SHALL BE \$0.70 PER TON.
