

3. EXTENSION OF TERM, DREDGING PERMIT P.R.C. 3486.1; MARIN COUNTY; MARIN COUNTY FLOOD CONTROL AND WATER CONSERVATION DISTRICT - W.O. 6703.

After consideration of Calendar Item 23 attached, and upon motion duly made and carried, the following resolution was adopted:

THE COMMISSION APPROVES:

1. THE EXTENSION THROUGH DECEMBER 31, 1968, OF DREDGING PERMIT P.R.C. 3486.1, COVERING A PORTION OF TIDE AND SUBMERGED LANDS, CORTE MADERA CREEK AND CORTE MADERA CANAL, MARIN COUNTY; AND
2. THE EXTENSION THROUGH DECEMBER 31, 1968, OF THE ASSIGNMENT OF THAT PORTION OF STATE LEASE P.R.C. 1500.1 WHICH IS INCLUDED WITHIN P.R.C. 3486.1

THE APPROVAL OF THE PERMIT AND OF THE ASSIGNMENT EXTENSIONS FOR THE PERIOD MARCH 1, 1968, THROUGH DECEMBER 31, 1968, SHALL BE SUBJECT TO APPROVAL FOR THE SAME PERIOD OF THE EXTENSION OF THE PROJECT BY THE SAN FRANCISCO BAY CONSERVATION AND DEVELOPMENT COMMISSION.

EXTENSION

PERMIT: Dredging Permit F.R.C. 3486.1 (issued April 28, 1966, Minute Item No. 44, p. 12,625), including assignment from Schultz Investment Company to Marin County Flood Control and Water Conservation District of that portion of State Lease P.R.C. 1500.1 which is included within P.R.C. 3486.1 (assigned August 8, 1966, Minute Item 36, p. 13,037)

PERMITTEE: Marin County Flood Control and Water Conservation District

LOCATION: Tide and submerged lands, Corte Madera Creek and Corte Madera Canal, Marin County

PERMIT EXPIRATION DATE: December 31, 1967

ASSIGNMENT EXPIRATION DATE: February 16, 1968

ORIGINAL AMOUNT TO BE DREDGED AND ITS DEPOSITION: 380,000 cubic yards, to be deposited on public and private lands, at a royalty of \$0.01 per cubic yard for all material to be placed on private property

REASON FOR EXTENSION: Opening of bids by U.S. Army Corps of Engineers for first phase of work has committed successful bidder to work beyond expiration date of permit

BASIS FOR CONSIDERATION OF EXTENSION: To allow time for State permittee to complete project under the circumstances, and, ultimately, to increase revenue to State

OTHER PERTINENT INFORMATION:

- a. ALL State agencies have previously approved project
- b. U.S. Corps of Engineers are sponsoring project and therefore require no permit
- c. San Francisco Bay Conservation and Development Commission has granted permittee a six month time extension to March 1, 1968

IT IS RECOMMENDED THAT THE COMMISSION APPROVE:

1. THE EXTENSION THROUGH DECEMBER 31, 1968, OF DREDGING PERMIT P.R.C. 3486.1, COVERING A PORTION OF TIDE AND SUBMERGED LANDS, CORTE MADERA CREEK AND CORTE MADERA CANAL, MARIN COUNTY; AND
2. THE EXTENSION THROUGH DECEMBER 31, 1968, OF THE ASSIGNMENT OF THAT PORTION OF STATE LEASE P.R.C. 1500.1 WHICH IS INCLUDED WITHIN P.R.C. 3486.1.

THE APPROVAL OF THE PERMIT AND OF THE ASSIGNMENT EXTENSIONS FOR THE PERIOD MARCH 1, 1968, THROUGH DECEMBER 31, 1968, SHALL BE SUBJECT TO APPROVAL FOR THE SAME PERIOD OF THE EXTENSION OF THE PROJECT BY THE SAN FRANCISCO BAY CONSERVATION AND DEVELOPMENT COMMISSION.
