6. DREDGING PERMIT, NAPA RIVER, NAPA COUNTY; TRANS-BAY CONSTRUCTORS - N.O. 6879, P.R.C. 3877.9.

After consideration of Calendar Item 34 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE COMMESSION AUTHORIZES THE ISSUANCE OF A PERMIT TO THE TRANS-BAY CONSTRUCTORS TO DREDGE APPROXIMATELY 4000 CUBIC YARDS OF MATERIAL FROM A TRIANGULAR AREA OF SUBMERGED LANDS WITHIN THE BED OF THE NAPA RIVER THAT CONTAINS APPROXIMATELY 0.6 ACRE, THE CENTER OF WHICH IS LOCATED AT LATITUDE 38° 15' 15" N., LONGITUDE 122° 17' 03" W., AND WHICH IS ON THE WEST SIDE OF THE MAPA RIVER DEDERAL NAVIGATION CHANNEL AT THE NORTH CONFLUENCE OF THE RIVER WITH HORSESHOE BEND, AND IS LOCATED APPROXIMATELY 3.0 MILES SOUTH OF THE CITY OF NAPA IN NAPA COUNTY.

### DREDGING PERMIT

APPLICANT: Trans-Bay Constructors

LOCATION: Submerged lands, Napa River, Napa County

PURPOSE: In order to dry-dock a portion of the Trans-Bay Tube Section No. 1 at the Kaiser Steel Corporation Drydock No. 4, the proposed dredging is necessary to float the tube section in for modification. This is part of BARTD project.

AMOUNT TO BE DREDGED: 4000 cubic yards

DISPOSITION OF DREAGED MATERIAL:

Approximately 4000 cubic yards of silt to be disposed of in Carquinez Strait east and west of the entrance to Mare Island (see Exhibit "A")

CONSIDERATION: The public benefit

BASIS FOR CONSIDERATION: See purpose and disposition

IT IS RECOMMENDED THAT THE COMMISSION AUTHORIZE THE ISSUANCE OF A PERMIT TO THE TRANS-BAY CONSTRUCTORS TO DREDGE APPROXIMATELY 4000 CUBIC YARDS OF MATERIAL FROM A TRIANGULAR AREA OF SUBMERGED LANDS WITHIN THE BED OF THE MAPA RIVER THAT CON-TAINS APPROXIMATELY 0.6 ACRE, THE CLANTER OF WHICH IS LOCATED AT LATITUDE 38° 15' 15" N., LONGITUDE 122° 17' 03" W., AND WHICH IS ON THE WEST SIDE OF THE NAPA RIVER FEDERAL NAVIGATION CHANNEL AT THE NORTH CONFLUENCE OF THE RIVER WITH HORSESHOE BEND, AND IS LOCATED APPROXIMATELY 3.0 MILES SOUTH OF THE CITY OF MAPA IN MAPA COUNTY.
