The City of Long Beach, pursuant to the provisions of Section 5(g), Chapter 138, Statutes of 1964, 1st E.S., has requested State Lands Commission approval of the First Modification of the Plan of Development and Operations and Budget, January 1, 1968, through June 30, 1968, Long Beach Unit.

The Commission, at its meeting of October 26, 1967, approved the Plan of Development and Operations and Budget for the period January 1, 1968, through June 30, 1968. The Plan and Budget, as approved, provides for cellars and rig rails on Islands Charlie and Delta.

This requested modification will provide \$85,000 to install rig rails which are needed in order to move the drilling rig between two cellars on Island Alfa. Funds for purchase of these rig rails were provided in the 1967 Budget.

This First Modification, as detailed in THUMS Approval Request 26-67, will become an addition on page 30 of the Plan and Budget as follows:
