5. RIGHT-OF-WAY PERMIT, AMERICAN RIVER, SACRAMENTO COUNTY; SACRAMENTO MUNICIPAL UTILITY DISTRICT - W.O. N-0093, P.R.C. 3900.9.

After consideration of Calendar Item 3 attached, and upon motion duly made and carried, the following resolution was adopted:

THE COMMISSION AUTHORIZES THE ISSUANCE TO SACRAMENTO MUNICIPAL UTILITY DISTRICT OF A 49-YEAR RIGHT-OF-WAY PERMIT FROM JANUARY 15, 1968, PURSUANT TO SECTIONS 12808 AND 10151 OF THE PUBLIC UTILITIES CODE, FOR INSTALLATION AND MAINTENANCE OF A POWER LINE ON THE LAND DESCRIBED ON EXHIBIT "A" ATTACHED AND BY REFERENCE MADE A PART HEREOF.

RIGHT-OF-WAY PERMIT

APPLICANT: Sacramento Municipal Utility District

LOCATION: A 20 x 815-foot strip of land in American River approximately 8000 feet downstream from Watt Avenue Bridge, Sacramento

PROPOSED USE: The installation of a 69-KV overhead power line

TERM: 49 years, from January 15, 1968

CONSIDERATION: No charge pursuant to Sections 12808 and 10151 of the Public Utilities Code

PREREQUISITE ITEMS:

U.S.A. Corps of Engineers permit is not required.  
 Applicant is acquiring appropriate property rights in the upland.

EXHIBIT "A"

A portion of Sections 10 and 11, Township 8 North, Range 5 East, Mount Diablo Base and Meridian.

The route of said right of way shall be within a strip of land of the uniform width of 20 feet, the center line of which is described as follows: Beginning at a point on the North line of that certain Record of Survey entitled "Portion of Sections 10, 11, 14 and 15, T. 8 N., R. 5 E., M.D.B.& M." recorded in the office of the Recorder of Sacramento County on October 14, 1959, in Book 15 of Surveys, Map No. 2, from which point the Northwest corner of said Record of Survey bears the following two courses: (1) South  $81^{\circ} 53' 45''$  West along the Northerly line of said Survey 35.50 feet and (2) South  $70^{\circ} 31' 20''$  West along the Northerly line of said Survey 59.00 feet; thence from said point of beginning North  $02^{\circ} 20' 08''$  West 815 feet to a point on the mean low water line of the right or Northerly bank of the American River; EXCEPTING THEREFROM any part thereof extending beyond the boundaries of the strip of sovereign lands comprising the bed of the American River in its last natural location.
