28. RENEWAL OF LEASE P.R.C. 570.1, SUBMERGED LAND, SACRAMENTO RIVER, COLUSA COUNTY; SHELL OIL COMPANY - W.O. 5873.

After consideration of Calendar Item 2 attached, and upon motion duly made and carried, the following resolution was adopted:

THE COMMISSION AUTHORIZES THE ISSUANCE TO SHELL OIL COMPANY OF A 10-YEAR RENEWAL, FROM DECEMBER 18, 1965, OF LEASE P.R.C. 570.1, COVERING A PARCEL OF SUBMERGED LAND IN SACRAMENTO RIVER IN COLUSA COUNTY, IN CONSIDERATION OF ANNUAL RENT IN THE AMOUNT OF \$150, FOR CONTINUED MAINTENANCE OF AN OIL DOCK ON THE LAND DESCRIBED IN SAID LEASE; PROVIDED THAT ALL OTHER TERMS AND CONDITIONS THEREOF SHALL REMAIN IN FULL FORCE AND EFFECT.

RENEWAL OF LEASE P.R.C. 570.1

APPLICANT: Shell Oil Company

LOCATION: A 0.42-acre parcel of submerged land in Sacramento River at Colusa, Colusa County

PRESENT USE: The maintenance of an existing oil dock

TERMS OF BASIC LEASE:

Initial Period: 15 years, from December 18, 1950  
Renewal options: 2 additional periods of 10 years each  
Surety bond: \$1,000

CONSIDERATION: (1) During initial lease period: \$50 per annum  
(2) During renewal period, December 18, 1965, to December 17, 1975: \$150 per annum

BASIS FOR CONSIDERATION DURING RENEWAL PERIOD:

\$150 minimum rental for this type of lease or permit
