3. INDUSTRIAL LEASE (RIGHT OF WAY), TIDE AND SUBMERGED LANDS, SACRAMENTO RIVER, SACRAMENTO COUNTY; GENERAL TELEPHONE COMPANY OF CALIFORNIA - W.O. N-0122, P.R.C. 3925.9.

After consideration of Calendar Item 16 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE COMMISSION AUTHORIZES THE EXECUTION OF AN AGREEMENT WITH THE GENERAL TELEPHONE COMPANY OF CALIFORNIA PURSUANT TO THE PROVISIONS OF SECTION 7901 OF THE PUBLIC UTILITIES CODE AND OF ATTORNEY GENERAL'S OPINION 52/56, IN THE FORM PREVIOUSLY ADOPTED BY THE COMMISSION, APPROVING THE LOCATION OF A TELEPHONE CABLE ACROSS TIDE AND SUBMERGED LAND IN THE SACRAMENTO RIVER, SACRAMENTO COUNTY, AS DESCRIBED ON EXHIBIT "A" ATTACHED AND BY REFERENCE MADE A PART HEREOF.

INDUSTRIAL LEASE (RIGHT OF WAY)

APPLICANT: General Telephone Company of California

LOCATION: A 2.5-x 806-foot strip of tide and submerged land in Sacramento River southerly of Courtland, Sacramento County

PROPOSED USE: Installation of cable for telephone transmission

TERM: Indefinite duration

CONSIDERATION: No monetary consideration, pursuant to Section 7901, Public Utilities Code

Lessee: General Telephone Company

A parcel of land located in the north half of the northwest quarter ($N\frac{1}{2}$ of $NW\frac{1}{4}$) of Section eight (8), Township five (5) north, Range four (4) east, M.D.M., said parcel being a strip of land five (5) feet in width lying two and one-half ($2\frac{1}{2}$) feet on each side of the following described centerline:

BEGINNING at a point in the north half of the northeast quarter of said Section 8 on the ordinary high water line of the East bank of the Sacramento River 485 feet south of a monument designated S.M. 48 (Division of Highways information), thence South $68^{\circ} 15'$ West 321 feet more or less to a point on the ordinary high water line on the opposite bank of said river and the end of the herein described centerline.
