38. PROPOSAL OF THE CITY OF LONG BEACH TO EXPEND TIDELAND OIL REVENUES, MARINE STADIUM WEST - LBWO 10,204.

After consideration of Calendar Item 4 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE COMMISSION DETERMINES THAT THE EXPENDITURE PROPOSED AT MARINE STADIUM WEST OF APPROXIMATELY \$37,400 (AS DETAILED ON ATTACHED EXHIBIT "A"), BY THE CITY OF LONG BEACH FROM ITS SHARE OF TIDELAND OIL REVENUES, TO CONSTRUCT AN OVERHEAD LANE MARKER SYSTEM IS IN ACCORDANCE WITH THE PROVISIONS OF CH. 138/54, 1ST E.S.; SAID DETERMINATION TO BE SUBJECT TO THE CONDITION THAT THE WORK CONFORM IN ESSENTIAL DETAIL TO THE PLANS AND BACKGROUND MATERIAL HERETO ONE SUBMITTED.

Suspended cables at 1000 m., 1500 m., and 2012 m., lines to support 6 lane markers on each cable. Condition at 1000 m. line requires dolphin support or other special treatment.
