6. PUBLIC AGENCY FILL PERMIT, GUADALUPE RIVER, SANTA CLARA COUNTY; SANTA CLARA COUNTY FLOOD CONTROL AND WATER DISTRICT - W.O. 6614, P.R.C. 3950.9.

After consideration of Calendar Item 6 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE COMMISSION AUTHORIZES THE ISSUANCE TO THE SANTA CLARA COUNTY FLOOD CONTROL AND WATER DISTRICT OF A ONE-YEAR PERMIT TO DEPOSIT FILL IN THE GUADALUPE RIVER, SANTA CLARA COUNTY, FROM MAY 23, 1968, IN CONSIDERATION OF THE PUBLIC BENEFIT, ON THE LAND DESCRIBED ON EXHIBIT "A" ATTACHED AND BY REFERENCE MADE A PART HEREOF.

PUBLIC AGENCY FILL PERMIT

APPLICANT: Santa Clara County Flood Control and Water District
LOCATION: Santa Clara County
PROPOSED USE: To deposit fill material in a portion of the bed of the
Guadalupe River
TERMS: 1 year, from May 23, 1968
CONSIDERATION: The public benefit and the improvement of the State lands

The fill is necessary to protect flood control improvements and as a preliminary step for a proposed exchange of land by which access would be provided to private property cut off from the channel.

EXHIBIT "A"

A parcel of land in the bed of the Guadalupe River in Sec. 9, T. 6 S., R. 1 W., MDM, more particularly described as follows:

Commencing at the monument set at the center line intersection of Moffat and Liberty Streets, as designated on the Map entitled, "Plat of the Western Section of Alviso", and which Map was recorded in the office of the County Recorder of the County of Santa Clara, State of California, on July 29, 1869 in Book "A" of Maps, page 45, records of said County; thence along the center line of said Liberty Street South $0^{\circ} 53' 45''$ West 420.00 feet to the Southerly line of Washington Street; thence along the said Southerly line of Washington Street North $89^{\circ} 06' 15''$ West 40.00 feet to a point on the present East bank of the Guadalupe River; thence along said present East bank South $00^{\circ} 54' 30''$ West 76.88 feet; thence South $18^{\circ} 20' 45''$ West 216.99 feet; thence South $33^{\circ} 48' 55''$ West 19.31 feet to the TRUE POINT OF BEGINNING;

THENCE from said true point of beginning continuing along said East bank South $33^{\circ} 48' 55''$ West 255.69 feet and South $41^{\circ} 26' 05''$ East 60.00 feet; thence leaving said present East bank South $65^{\circ} 30' 00''$ West (scaled) 116.00 feet (scaled) to the angle point on the present West bank of the Guadalupe River between Courses 36 and 37 as shown on the Santa Clara County Flood Control and Water District map (Job No. 30016); thence along said present West bank the following four (4) courses:

North $15^{\circ} 16' 15''$ West 77.43 feet; thence
 North $11^{\circ} 07' 45''$ East 93.94 feet; thence
 North $25^{\circ} 31' 45''$ East 50.21 feet; thence
 North $35^{\circ} 35' 45''$ East 151.75 feet; thence

leaving said West line South $80^{\circ} 30' 00''$ East (scaled) 108.00 feet (scaled) to the true point of beginning.
