# GTHER PERTIMENT INFORMATION:

By Resolution of August 15, 1966 (Minute Item 3, p. 12754), the Commission authorized issuance of a 15-year easement to the applicants, with three 10-year renewal options, at an annual rental of \$150 and provision of a \$2000 surety bond. The applicants declined to agree to the terms as authorized, maintaining that the bridge and roadway were more in the nature of a right of way qualifying for a reduced rental pursuant to current policy. They also maintained that the previous requirement of a \$2000 bond is excessive. Staff has reviewed the transaction and, after renegotiation with the principals, recommends that the amended term, rental, and bond requirement be substituted for those included in the prior resolution.
