

25. MODIFICATION OF FORM FOR GEOPHYSICAL SURVEY PERMITS ON TIDE AND SUBMERGED LANDS OF THE STATE OF CALIFORNIA - W.O. 7048.

After consideration of Calendar Item 30 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE COMMISSION:

1. ADOPTS THE FORM OF GEOPHYSICAL SURVEY PERMIT ON FILE IN THE OFFICE OF THE STATE LANDS COMMISSION AS EXHIBIT "A" AND BY REFERENCE MADE A PART HEREOF;
2. AUTHORIZES UTILIZATION OF THE AFORESAID ADOPTED FORM OF THE PERMIT FOR THE ISSUANCE OF ANY NEW GEOPHYSICAL PERMITS OR EXTENSIONS OF EXISTING PERMITS.

MODIFICATION OF FORM FOR GEOPHYSICAL SURVEY PERMITS ON TIDE AND SUBMERGED LANDS OF THE STATE OF CALIFORNIA - W.O. 7048.

The standard form of permit for the conduct of geophysical survey operations on tide and submerged lands of the State of California was approved by the State Lands Commission under W.O. 4961 on December 20, 1963. The subsequent geophysical permits granted by the Commission for seismic operations in the area lying between the seaward extension of the northern boundary of Mendocino County and the southern boundary of the State of California were issued in three parts, A, B, and C. Each part, utilizing the standard form of the permit, covered a different portion of the California offshore tide and submerged lands, listing the excluded areas and limiting the distances of permissible seismic shots in certain offshore sections.

In order to facilitate the issuance of geophysical permits and reduce the man-hours necessary to process the permits, it is desirable to combine the three parts into one permit, utilizing a standard form of permit and incorporating all the exclusions and limitations and all the operating conditions established by the Commission. The form of modified Permit for the Conduct of Geophysical Surveys on Tide and Submerged Lands of the State of California is attached hereto as Exhibit "A".

IT IS RECOMMENDED THAT THE COMMISSION:

1. ADOPT THE FORM OF GEOPHYSICAL SURVEY PERMIT ON FILE IN THE OFFICE OF THE STATE LANDS COMMISSION AS EXHIBIT "A" AND BY REFERENCE MADE A PART HEREOF;
2. AUTHORIZE UTILIZATION OF THE AFORESAID ADOPTED FORM OF THE PERMIT FOR THE ISSUANCE OF ANY NEW GEOPHYSICAL PERMITS OR EXTENSIONS OF EXISTING PERMITS.
