SEVENTH MODIFICATION OF THE PLAN OF DEVELOPMENT AND OPERATIONS AND BUDGET, LONG BEACH UNIT, JANUARY 1, 1968, THROUGH JUNE 30, 1968, WILMINGTON OIL FIELD, LOS ANGELES COUNTY - W.O. 5200.317.

The City of Long Beach, pursuant to the provisions of Section 5(g), Chapter 138/1964, 1st E.S., has requested State Lands Commission approval of the Seventh Modification of the Plan of Development and Operations and Budget, Long Beach Unit, January 1, 1968, through June 30, 1968.

The Plan and Budget for the first six months of 1968 provides for a quarterly modification to reflect any changes in the estimated ranges of rates of production and the estimated ranges of rates and pressures of injection, and to provide a report of each well completed and placed on production or injection.

The Second Modification of the subject Plan and Budget, approved by the Commission at its meeting of March 28, 1968, set forth revised estimated ranges and a report of well completions as of January 1, 1968. This proposed modification sets forth such data as of April 1, 1968.

The staff has reviewed the estimated ranges of rates of production and injection for the second quarter of 1968, as well as the report of each well on production or injection as of March 31, 1968, as set forth in THUMS Approval Request 14-68, and found them to be reasonable.
