11. DREDGING PERMIT, TIDE AND SUBMERGED LANDS, BODEGA HARBOR, SONOMA COUNTY; COUNTY OF SONOMA, PARKS AND RECREATION DEPARTMENT - W.O. 6999, P.R.C. 4012.9.

After consideration of Calendar Item 60 attached, and upon motion duly made and carried, the following resolution was adopted:

THE COMMISSION AUTHORIZES THE ISSUANCE TO THE COUNTY OF SONOMA, PARKS AND RECREATION DEPARTMENT, OF A PERMIT TO DREDGE 22,500 CUBIC YARDS OF MATERIAL FROM AN AREA OF TIDE AND SUBMERGED LANDS IN BODEGA HARBOR AND TO DEPOSIT THE DREDGED MATERIAL AT LOCATIONS WITHIN BODEGA HARBOR AND BAY. THE AREA TO BE DREDGED IS DESCRIBED ON EXHIBIT "A" ATTACHED AND BY REFERENCE MADE A PART HEREOF.

APPLICATION FOR DREDGING PERMIT

APPLICANT: County of Sonoma, Parks and Recreation Department

LOCATION: Bodega Harbor, Sonoma County

TYPE OF LAND: Tide and submerged land within legislative grant to Sonoma County, with mineral reservation to the State

PURPOSE: Construction of a boat launching ramp and channel

AMOUNT TO BE DREDGED:
22,500 cubic yards

DISPOSITION OF DREDGED MATERIAL:
Construction of nonrevenue-producing recreational features at locations within Bodega Harbor and Bodega Bay, all County of Sonoma properties

CONSIDERATION: Public benefit

OTHER PERTINENT INFORMATION:

- A. Proposed dredging project is part of County of Sonoma's Westside Park Project.
- B. The County has entered into an agreement with the United States Corps of Engineers for the Corps to conduct the proposed dredging project in conjunction with other work being done by the Corps in the area. No Department of the Army permit will be required.
- C. The proposed dredging project has been reviewed, with no adverse comments by the following State agencies:

Department of Harbors and Watercraft
State Water Resources Control Board
Department of Fish and Game, Wildlife Conservation Board
Department of Water Resources
- D. The State Department of Parks and Recreation has made an examination of the proposed project, pursuant to Section 6818 of the Public Resources Code, and has no objections.

EXHIBIT "A"

DREDGE AREA

Commencing at Monument 227 as shown on the Survey of the Legislative Grant to the County of Sonoma filed in Book 71 of maps on pages 4 - 9, Sonoma County Records, said Monument 227 bears S. 18° 47' 53" West, a distance of 1,201.26 feet from Monument 226 as shown on said map; thence from said point of commencement East 550.00 feet to the true point of beginning of the parcel herein described; thence from said point of beginning South 125 feet to a point, said point being the southwest corner of the herein described parcel; thence East 525 feet to a point, said point being the southeast corner of the herein described parcel; thence North 240 feet to a point, said point being the northeast corner of the herein described parcel; thence West 525 feet to a point, said point being the northwest corner of the herein described parcel; thence South 115 feet to the point of beginning, containing 2.892 acres more or less.
