12. GRAZING LEASE, RECESSION LANDS, INYO COUNTY; CABIN-BAR-RANCH, INC. -

After consideration of Calendar Item 25 attached, and upon motion duly made and carried, the following resolution was adopted:

THE COMMISSION AUTHORIZES THE ISSUANCE TO CABIN-BAR-RANCH, INC., OF A 10-YEAR GRAZING LEASE, FROM AUGUST 1, 1968, IN CONSIDERATION OF \$106.50 PER ANNUM, FOR GRAZING OF LIVESTOCK ON THE LAND DESCRIBED AS FOLLOWS:

GRAZING LEASE

APPLICANT: Cabin-Bar-Ranch, Inc.  
LOCATION: Approximately 2 miles north of Olancho, Inyo County  
PROPOSED USE: Grazing  
TERM: 10 years, from August 1, 1968  
CONSIDERATION: \$106.50 per annum

BASIS FOR CONSIDERATION:

An appraisal by the staff on March 22, 1968, indicates the fair grazing rental to be \$.15 per acre per year, or for 710 acres an annual rental of \$106.50. The rate per acre is consistent with the carrying capacity and corresponds with the rental rates of similar privately owned lands in the vicinity.
