A strip of tide and submerged land located in Section 34 and Section 35, Township 4 North, Range 6 East, M.D.M., said strip of land being twenty (20) feet wide extending across the Mokelumne River and lying fifteen (15) feet on the northwesterly side and five (5) feet ou the southeasterly side of the following described line:

BEGINNING at a point on the northeasterly or right bank of the Mokelumme River in said Section 35 from which a 2-inch iron jipe marking the northwest corner of said Section 35 bears N. 06° 06' W. 1120.1 feet; thence from said point of beinning, S. 46° 24' W. 185 feet more or less to a point on the southwesterly or left bank of said Mokelumme River and the end of the herein described line.
