- (1) The State land to be traversed is in a timbered, mountainous area about 12 airline miles south of the town of Chester in a remote area near the headwaters of Yellow Creek
- (2) The easement will be nonexclusive, and is to be for 49 years and so long thereafter as the land is used for a road. Section 2004(d) of the California Administrative Code provides that the term of any lease to the United States "... shall not exceed 49 years except by special resolution of the Commission". Since the effective term of the lease could exceed 49 years, a special resolution is required.
