EXHIBIT "A"

W.O. 6370

That portion of Section 36, Township 10 North, Range 15 East, San Bernardino Base and Meridian, lying within a strip of land TWO HUNDRED NINETY (290) feet wide, the side lines thereof being 80 reet Northerly and 210 feet Southerly, measured at right angles, respectively, from the surveyed reference line which is described as follows:

Beginning at a point in the Westerly line of Section 34, Township 10 North, Range 15 East, San Bernardino Base and Meridian, said point being North 000 47' 56" West 3133.57 feet, measured along said Westerly line from a 2" iron pipe with tag stamped "R.E. 7208", set at the Southwest corner of said Section 34; thence North 82° 20' 14" East 16,100.49 feet, more or less, to a point in the Easterly line, of said Section 36, last mentioned point being North 01° 21' 45" West 4998.92 feet, measured along said Easterly line from a U.S.G.L.O. Brass Cap Monument set at the Southeast corner of said Section 36, containing 35.73 acres more or less.

The side lines of said strip of land TWO HUNDRED NINETY (290) feet wide, shall be prolonged or shortened so as to terminate in the Easterly line of said Section 36.
