ASSIGNMENT OF LEASE P.R.C. 2610.1

ASSIGNORS: Edward C. and Gartha L. Zorn

ASSIGNEES: Marvin D. and Myrtle M. Clark

LOCATION: A 0.93-acre parcel of sovereign land in Mokelumne River $3\frac{1}{2}$ miles southeast of Isleton, Sacramento County

PRESENT USE: Operation of a marina

TERMS OF LEASE TO BE ASSIGNED:

Initial period: 15 years, from August 24, 1960
Renewal options: 2 additional periods of 10 years each
Surety bond: \$3,000
Public liability insurance: \$100,000/\$300,000 for personal injury

CONSIDERATION: \$150 per annum
