48. AWARD OF OIL AND GAS LEASE, PARCEL 36A, OFFSHORE GAVIOTA, SANTA BARBARA COUNTY; STANDARD OIL COMPANY OF CALIFORNIA - W.O. 6975, P.R.C. 4002.1.

After consideration of Calendar Item 53 attached, and upon motion duly made and carried, the following resolution was adopted:

THE COMMISSION ACCEPTS THE BID MADE BY STANDARD OIL COMPANY OF CALIFORNIA, AND AUTHORIZES THE ISSUANCE OF AN OIL AND GAS LEASE TO THE AFORESAID BIDDER FOR APPROXIMATELY 600 ACRES OF SUBMERGED LANDS DESIGNATED AS W.O. 6975 (PARCEL 36A) IN SANTA BARBARA COUNTY, AS DETAILED IN THE NOTICE OF INTENTION PUBLISHED MAY 8 AND MAY 15, 1968.
