53. AWARD OF OIL AND GAS LEASE, GRAY LODGE WATERFOWL MANAGEMENT AREA, BUTTE COUNTY; E. B. TOWNE, AN INDIVIDUAL - W.O. 6895, P.R.C. 4003.1.

After consideration of Calendar Item 50 attached, and upon motion duly made and carried, the following resolution was adopted:
