## MINUTE ITEM

57. AUTHORIZATION FOR FUBLICATION OF NOFICE-OF CONSIDERATION OF OIL AND GAS LEASE OFFER, TIDE AND SUBMERGED LANDS, 135 ANGELES AND ORANGE COUNTIES - W.O. 7094.

During consideration of Calendar Item 62 attached, Mr. H. A. Lingle, Deputy City Attorney for the City of Long Beach, appeared and asked that the City be consulted in connection with the proposed issuance of any leases.

The Executive Officer stated that a copy of the Notice of Intention would be transmitted officially to the City of Long Beach, pursuant to which a request can be submitted to the State Lands Commission to hold a hearing so that the desires of the City can be outlined to the Commission.

Upon motion duly made, seconded, and carried unanimously, the following resolution was adopted:

THE COMMISSION AUTHORIZES THE PUBLICATION OF A NOTICE, AS REQUIRED BY SECTION 6873.2 OF THE PUBLIC RESOURCES CODE, THAT THE COMMISSION INTENDS TO CONSIDER OFFERING FOR LEASE FOR THE EXTRACTION OF OIL AND GAS AN AREA OF TIDE AND SUBMERGED LANDS DESCRIBED AS FOLLOWS:

THAT AREA OF UNGRANTED STATE TIDE AND SUBMERGED LANDS, NOT INCLUDED IN EXISTING STATE OIL AND GAS LEASES, LYING BETWEEN THE WESTERLY BOUNDARY OF THE CITY OF LONG BEACH ON THE WEST AND THE SOUTHEASTERLY CITY LIMITS OF THE CITY OF HUNTINGTON BEACH AND THE SOUTHWESTERLY PROLONGATION THEREOF ON THE EAST, CONTAINING 18,000 ACRES MORE OR LESS.
