A parcel of submerged land lying in the bed of the Sacramento River, in the State of California, Sacramento County, and being more particularly described as follows:

COMMENCING at the northwest corner of Lot 7 of the Bates and Isham

Addition to Courtland, as recorded in the Sacramento County Recorder's

Office in Book 15 of Maps, Map 36; thence N. 48° 32' W., 142.04 feet;

N. 89° 35' W., 84.79 feet to a point on the left or easterly bank

of the Sacramento River, said point being at the intersection of a

line common to the fractional N½ of the NE¼ of Section 32, T. 6 N.,

R. 4 E., M.D.M., and the fractional S½ of the NE¼ of said Section 32,

said point being also the TRUE POINT OF BEGINNING of this description;

thence N. 47° 40' W., 70 feet; thence northeasterly 250 feet along

a line 70 feet distant, and parallel with said easterly bank; thence

S. 47° 40' E., 70 feet to a point on the easterly bank of the

Sacramento River; thence southeasterly along said bank 250 feet to

the point of beginning.

EXCEPTING therefrom all lands lying above the ordinary low water mark of the Sacramento River as would exist under natural conditions. Containing a gross area of 0.42 acre.
