## NONCOMMERCIAL LEASE

APPLICANT: South Tahoe Valhalla, Inc.

LOCATION: A 0.095-acre parcel of submerged land in Lake Tahoe near Tallac Village, El Dorado County

PROPOSED USE: The construction of a pier

TERM: 49 years, from September 1, 1968  
Surety bond: \$1000

CONSIDERATION: \$150 per annum during the first 5 years, with the State reserving the right to review and reset a reasonable rental on each fifth anniversary

BASIS FOR CONSIDERATION:  
6% of appraised value of land

PREREQUISITE ITEMS:  
U.S. Army Corps of Engineers permit issued  
Applicant is owner of upland

EXHIBIT "A"

All that tide and submerged land located on the bed of Lake Tahoe immediately adjacent to a portion of Lot 1, Section 25, Township 13 North, Range 17 East, M.D.M., said land more particularly described as follows:

BEGINNING at a point from which the northeast corner of said Lot 1 bears S. 76° 30' E. 350 feet; thence N. 13° 30' E. 160 feet; thence N. 76° 30' W. 70 feet; thence S. 13° 30' W. 30 feet; thence S. 76° 30' E. 40 feet; thence S. 13° 30' W. 130 feet; thence S. 76° 30' E. 30 feet to the point of beginning.

EXCEPTING THEREFROM that portion lying above the ordinary low water line.
