REQUEST FOR EXTENSION OF DREDGING PERMIT
P.R.C. 3458.9

APPLICANT: Department of Fish and Game, Region II

PERTINENT DATA:

1. Term of permit: March 31, 1966, to December 31, 1968
2. Dredge area: Montezuma Slough, from Roaring River to approximately Meins Landing, Solano County
3. Disposition of dredged material: Stockpile sites behind Montezuma Slough levee
4. Purpose: To stockpile 6000 cubic yards of material for levee maintenance

PRESENT REQUEST:

1. To extend expiration date of subject permit to December 31, 1970
2. To remove additional 15,050 cubic yards

REASON FOR REQUEST: To restock existing stockpile sites for levee maintenance

CONSIDERATION: Public benefit

OTHER PERTINENT INFORMATION:

The U.S. Army Corps of Engineers has issued a letter, dated September 6, 1968, revising the dredge area covered under Department of the Army Permit No. 4085 to include the area covered in P.R.C. 3458.9. Department of the Army Permit No. 4085 is effective to December 31, 1970.
