#### EXHIBIT "A"

A strip of land lying in the bed of the Sacramento River, Colusa County, California, located immediately north of the City of Colusa, and lying 12.5 feet on each side of the following described centerline:

COMMENCING at the intersection of 1st Street and Main Street in the City of Colusa, thence N. 30° 32' E., 104.68 feet; thence N. 21° 35' E., 185 feet to a point on the ordinary low water mark on the right bank of the Sacramento River, which point is the TRUE POINT OF BEGINNING; thence continuing from said true point of beginning, N. 21° 35' E., 255 feet more or less to a point on the ordinary low water mark on the left bank of the Sacramento River, which point bears S. 21° 35' W., 75 feet, more or less, from a point in an existing pole line and wire 12 KV distribution line, and the end of the herein described centerline.

EXCEPTING therefrom all lands lying above the ordinary low water mark of the Sacramento River as would exist under natural conditions.
