

24. GEOPHYSICAL SURVEY PERMIT, OFFSHORE AREA LYING BETWEEN MENDOCINO AND SAN DIEGO COUNTIES; CONTINENTAL OIL COMPANY - W.O. 7196, P.R.C. 4105.1.

UPON MOTION DULY MADE AND CARRIED, THE COMMISSION AUTHORIZED THE FOLLOWING:

THE ISSUANCE TO CONTINENTAL OIL COMPANY OF A GEOPHYSICAL SURVEY PERMIT ON TIDE AND SUBMERGED LANDS UNDER THE JURISDICTION OF THE STATE LANDS COMMISSION LYING BETWEEN THE SEAWARD EXTENSION OF THE NORTHERN BOUNDARY OF MENDOCINO COUNTY AND THE SOUTHERN BOUNDARY OF THE STATE OF CALIFORNIA, FOR THE PERIOD NOVEMBER 21, 1968, THROUGH MAY 20, 1969, UTILIZING THE FORM OF GEOPHYSICAL SURVEY PERMIT APPROVED BY THE COMMISSION ON JULY 17, 1968 (W.O. 7048, MINUTE ITEM 25, PAGE 862), AND EXEMPTING THEREFROM, IN ADDITION TO THE EXCLUSIONS OUTLINED IN THE FORM OF PERMIT, ALL THOSE LANDS IN MONTEREY BAY. THIS PERMIT IS TO SUPERSEDE GEOPHYSICAL SURVEY PERMITS P.R.C. 3325.1 AND P.R.C. 3706.1.

APPLICATION FOR GEOPHYSICAL SURVEY PERMIT

APPLICANT: Continental Oil Company

LOCATION: The offshore area lying between the seaward extension of the northern boundary of Mendocino County and the southern boundary of the State of California

METHOD OF EXPLORATION:
Seismic

TERM: From November 21, 1968, through May 20, 1969

FILING FEE: \$5 submitted

EXPENSES: To be reimbursed by the permittee

PREREQUISITE: Fish and Game Commission permit

OPERATING CONDITIONS:

OTHER PERTINENT INFORMATION:

Continental Oil Company has been conducting seismic operations in State waters under two geophysical survey permits, P.R.C. 3325.1 expiring on January 1, 1969, and P.R.C. 3706.1, expiring on January 23, 1969; and is now requesting that these two permits be combined into one permit.
