37. DEFERMENT OF DRILLING REQUIREMENTS, P.R.C. 3150.1, CARPINTERIA OFFSHORE, SANTA BARBARA COUNTY; STANDARD OIL COMPANY OF CALIFORNIA AND ATLANTIC RICHFIELD COMPANY - W.O. 7035.

After consideration of Calendar Item 15 attached, and upon motion duly made and carried, the following resolution was adopted:

THE COMMISSION AUTHORIZES THE GRANTING TO STANDARD OIL COMPANY OF CALIFORNIA, WESTERN OPERATIONS, INC., OF A DEFERMENT OF DRILLING REQUIREMENTS UNDER OIL AND GAS LEASE P.R.C. 3150.1 THROUGH JUNE 28, 1969; ALL OTHER TERMS AND CONDITIONS OF THE LEASE TO REMAIN IN FULL FORCE AND EFFECT.

DEFERMENT OF DRILLING REQUIREMENT

P.R.C.: 3150.1

LESSEE: Standard Oil Company of California and
Atlantic Richfield Company

OPERATOR: Standard Oil Company of California,
Western Operations, Inc.

COUNTY: Santa Barbara

AREA: Carpinteria offshore

ISSUED: July 28, 1964

WORK COMPLETED ON LEASE: Constructed 2 drilling and producing platforms,
"Hope" and "Heidi". Drilled 63 wells and 2 core
holes; 60 wells currently producing.

PREVIOUS DEFERMENTS: From March 11, 1968, through September 10, 1968

THIS DEFERMENT: From December 29, 1968, through June 28, 1969

REASON FOR REQUEST: The drilling rig on platform "Hope" is presently
drilling into an adjacent State lease held by lessee,
in order to prevent drainage to said lease by pro-
duction on the adjoining Federal lease. After the
drilling of additional four wells, the rig will be
available for drilling on lease P.R.C. 3150.1. The
operator also requests additional time to continue
reservoir performance and engineering studies to
determine the prospects for further developmental
drilling.

IT IS RECOMMENDED THAT THE COMMISSION AUTHORIZE THE GRANTING TO STANDARD OIL COMPANY OF CALIFORNIA, WESTERN OPERATIONS, INC., OF A DEFERMENT OF DRILLING REQUIREMENTS UNDER OIL AND GAS LEASE P.R.C. 3150.1 THROUGH JUNE 28, 1969; ALL OTHER TERMS AND CONDITIONS OF THE LEASE TO REMAIN IN FULL FORCE AND EFFECT.
